

DATA PROTECTION PROCESSING CONSENT FORM

IWBF DATA PROTECTION NOTICE

The International Wheelchair Basketball Federation, c/o FIBA, Route Suisse, 5, PO Box 29, 1295 Mies, Switzerland ("IWBF") is aware that you care about how your personal information is used and shared, and appreciates your trust that IWBF will do so carefully and sensibly. This Data Protection Notice explains how IWBF and its affiliates (hereinafter "we") process Personal Data. Throughout this Data Protection Notice, the term "Personal Data" means information relating to an identified or identifiable individual (i.e. a natural person), e.g. name, address, telephone number, health information, etc. This Notice applies to the collecting or processing of your Personal Data.

1. The collection of information

1.1 How we use it?

The collection and use of your Personal Data will always have a lawful basis, either because it is necessary for our performance of a contract with you, because you have consented to our use of your Personal Data or because it is in our legitimate interests. Specifically, we may use your Personal Data for the following purposes: to manage your registration, your profile or your accreditation, to manage your licenses, to provide the necessary support for your transfer, to administer your membership, to create your team profile, to communicate with you and to enable users to enjoy all other services.

Your health information shall be solely collected by IWBF upon your express consent. IWBF uses such information to assess your eligibility as wheelchair basketball player whether for IWBF competitions or for Paralympic competitions. In this regard, by granting your approval to IWBF to collect and process your health information, you also consent for these information to be shared with third parties such as the International Paralympic Committee (IPC), for the sole purpose of assessing your eligibility as a wheelchair basketball player and ensure your compliance with IWBF's regulations.

We apply very high data protection standards. In particular, we will not disclose any Personal Data to third parties unless authorized to do so by law or by virtue of your consent (which does not in any way restrict our rights as provided by the applicable laws).

1.2 What do we collect from you?

The Personal Data collected may include but is not limited to the following personal information: email address, last name, first name, country of residence, date of birth, gender, screen name, password, ID addresses and opt-in for game and IWBF content preferences, health related information (upon prior approval).

1.3 How long will we keep your personal data?

We will retain your personal information on our systems only for as long as we need it, given the purposes for which it was collected, or as required to do so by law.

1.4 The policy towards children

IWBF is concerned about the safety and privacy of all its users, particularly children. We do not knowingly collect or solicit personal information from anyone under the age of 18 or knowingly allow such persons to provide us with their personal information without verifiable parent or guardian consent.

2. Your rights

You have certain rights related to your personal data. These rights include:

- · The right to be informed about our collection and use of your personal information;
- The right to access the personal information we have stored concerning you and the purpose for which it was stored;
- The right to ask for data correction if any personal information we hold about you is inaccurate or incomplete;
- The right to be forgotten, meaning the right to ask us to delete personal data;
- · The right to restrict the processing of your personal information;
- The right of portability (obtaining a copy of your Personal Data to be transferred to another data controller);
- The right to object using your Personal Data for particular purposes;
- The right to withdraw your consent to our processing of your personal data, given that the processing is based on your consent;
- · You may also submit a complaint to the responsible data protection supervisory authority.

If you want to contact us, please send us an email to Operations. Classification@iwbf.org. We may require you to provide verification of your identity. Please note that in certain circumstances we may withhold access to your Personal Data where we have the right to do so under current data protection legislation.

3. Information sharing and disclosure

IWBF will not sell or rent your Personal Data without your consent. Nevertheless, IWBF may share certain category of your Personal Data to third party service providers, governing bodies for basketball or IWBF partners when:

- · IWBF has your consent to share the Personal Data;
- · IWBF needs to share your Personal Data to provide the product or service you have requested;
- · IWBF needs to send your Personal Data to third parties who work on behalf of IWBF to provide a product or service to you (unless otherwise stated so, these third parties do not have any rights to use the Personal Data provided by IWBF beyond what is necessary to provide a product or service to you);
- · IWBF is required to share your Personal Data by courts or authorities; or
- · IWBF believes it is necessary to investigate, prevent or take action regarding illegal activities, suspected fraud, emergency situations involving potential threats to the physical safety of any person, violations of any of our terms and conditions, breach of IWBF's regulations or as otherwise required by law.



4. Other data protection information

4.1 International data transfers

Your Personal Data may be processed outside the country where you are located depending on the location third party service providers, governing bodies for basketball or IWBF partners who are permitted to access such Personal Data under the terms of this Data Protection Notice. Consequently, you acknowledge that Personal Data which is accessible to other users may be transferred to countries that do not benefit from the same level of Data Protection.

In such cases, we will take all reasonable steps to ensure that your Personal Data is treated safely and securely.

4.2 Security

If you communicate with IWBF by e-mail, through our Social media platform, or through other communication internet channels, you should note that the secrecy of internet is uncertain. By sending sensitive or confidential messages or information which are not encrypted you accept the risk of such uncertainty and possible lack of confidentiality over the Internet. In certain areas, IWBF uses industry standard SSL encryption to protect data transmissions.

5. Changes to this Data Protection Notice

We reserve the right to amend this Data Protection Notice at any time without providing reasons. If we amend this Data Protection Notice, any changes will be immediately posted on the IWBF Website and you will be deemed to have accepted the terms of the Data Protection Notice on your first use. We shall place an updated version on this page of the IWBF website.

7. Jurisdiction and application law

In the event that the provisions of this Data Protection Notice conflict with the provisions of third-party similar documents, the provisions of this Data Protection Notice shall prevail.

This Data Protection Notice and all matters arising out of or related to this Data Protection Notice shall be governed by the substantive laws of Switzerland, without regard to conflicts of laws and principles thereof.

Any controversy, claim or dispute between you and IWBF arising out of or relating to this Data Protection Notice shall be subject to the exclusive jurisdiction of the competent Court of Arbitration of Sports of the City of Lausanne, and each party hereby irrevocably consents to the jurisdiction and venue of such Court.
